To maintain Toronto Pearson's Airport Operating Certificate by ensuring compliance with the Canadian Aviation Regulations (CARs). Responsible for the Airport Operations Manual (AOM), aeronautical information and related aviation regulatory compliance programs.

#### **Key Accountabilities:**

- Lead all aspects of the interpretation of the Aeronautics Act, the Canadian Aviation Regulations (CARs) and associated standards, the Aerodrome Standards and Recommended Practices Publications (TP 312 & TP 7775) and as applicable Transport Canada Advisory Circulars
- Manage and maintain the Airport Operations Manual (AOM) in accordance with the CARs and TP 312
- Own and maintain the following plans in accordance with the CARs:
  - o Regulatory Exemptions/Modification of Standards (MOS);
  - o Canada Air Pilot (CAP);
  - o Canada Flight Supplement (CFS) (aerodrome specifications);
  - Minimum Equipment List (MEL);
  - o Code F / AGN VI Plan;
  - Airside Self Inspection Program;
  - o Surface Closure Policy; and
  - GTAA Apron Design Standards.
- Support relationship with Transport Canada (TC) for all CARs related activities, including the Airport Operations Manual (AOM), Aviation SMS, ARFF, Wildlife, Deicing
- Conduct reviews of the Government of Canada Gazette Parts I, II and III, Notice of Proposed Amendments,
  Advisory Circulars and develop impact assessments to determine impact to aviation operations
- Assist in providing input to National and International regulatory bodies to influence regulatory development
- Preparation and submission of documentation to Transport Canada:
  - Related to regulatory exemptions / modification of standards including risk assessments, impact statements, applications and formal requests;
  - Ensure plans of constructions for airside construction projects are aligned with CARs TP 312 and TP 7775;

- Complete Aviation Safety Management System (SMS) Level 1, 2 and 3 risk assessments on systems and programs as required for regulatory changes and events related to the AOM
- Complete Concern Reviews
- Write RFPs and handle contracts for ICAO Type A and OLS Surveys as required
- Prepare for and engage in internal and external audits
- Deliver on the People Manager Promise to support and further the business' vision through building and development of diverse, multi-skilled teams
